

Terms and Conditions:

The discounts associated with the **Gonzales Dental Plan** are available only through Dr. Lisa Gonzales.

Monthly membership fees are to be paid for a minimum twelve (12) month period and are non-refundable. Unless waived by the dentist, membership will automatically renew on the anniversary date and continue thereafter until cancelled in writing. In the event you need to cancel your policy with us, we ask that you give 30 days notice in writing in order to cancel this policy.

Qualified dependents are defined as applicant, applicant's legal spouse, and any non-married dependent children under age 22, living in the household. Any additional dependents after three (3) each will have an additional surcharge of \$15 per month per dependent.

Fees and plan discounts are subject to change without notice.

Missed or broken appointments without 24-hour notice will be charged \$45.00.

All member co-payments are due at time of service.

Membership in the Dental Plan may be terminated for abuse or failure to pay membership fees or properly billed work.

The **Gonzales Dental Plan** is administered solely by the dental office and may be discontinued at the end of any month, with or without notice.

Plan Limitations and Exclusions:

Gonzales Dental Plan benefits are limited to \$1250 per each covered family member, per year.

Dental plan benefits are not applicable until three (3) months after the initial date of acceptance except for Type I services.

Prophylaxis is limited to once every six (6) months. A difficult prophylaxis constitutes a category III cleaning and is subject to a \$20 surcharge.

Fluoride treatments are limited to once every six (6) months per member up to age 16.

Plan Limitations and Exclusions (continued):

A denture, bridge, crown, or other appliance installed under the **Gonzales Dental Plan** can be replaced only once during the period of five (5) years after the original installation. A denture, bridge, crown, or other appliance can be replaced only if it is unsatisfactory and which cannot be made satisfactory by a relining or repair.

Denture and partial relines are limited to once per calendar year.

All covered replacements are subject to the co-payment percentages as listed in the Schedule of Services.

Replacement of a satisfactory filling is excluded.

Any dental procedure in progress or performed before or after a member's eligibility period is excluded.

Any dental procedure not listed as a covered service, including but not limited to, anesthesia, prescription medications, emergency office visits, etc. is excluded.

Treatment required due to hospital and medical charges or self-inflicted wounds of any kind is excluded.

Treatment to correct congenital, developmental, or medically induced dental disorders is excluded (i.e. TMJ).

Replacement for lost or stolen dentures, partials, or appliances is excluded.

Bleaching of teeth, for cosmetic purposes, is excluded.

Any dental expense incurred if the dentist is unable to perform a procedure due to the member's general health or physical condition is excluded.

Any dental services provided to the member by state, county, or municipal agencies or dental services provided without cost to the member are excluded.

Coordination of **Gonzales Dental Plan** benefits with other dental or insurance plans is excluded.

How Does the Premium Plan Work?
